# Letter from LCA President Chris DeRose

This year was a demanding and successful one for us here at Last Chance for Animals and I am happy to report a great win for the animals. The notorious Class "B" animal dealer C.C. Baird was finally convicted of civil and criminal charges stemming from our undercover investigations and was **PUT OUT OF BUSINESS FOR GOOD!** His sentencing for criminal charges is due very soon, and should include jail time and steep fines. This victory is sweet justice for the thousands of animals Baird abused and killed during the years he operated as a Class "B" dealer. We are very happy to add C.C. Baird's name to the "busted" list of Class "B" dealers. LCA will not stop until we bust all Class "B" dealers guilty of stealing companion animals.


LCA also traveled to Louisiana to help rescue animals left behind in the aftermath of Hurricane Katrina. Abandoned, scared and starving dogs and cats – companion animals to many folks who lost everything – needed help desperately. Being in the hurricane's "hot zone" was an intense experience LCA's rescue team will never forget.

We embarked on our "Elephant Sanctuaries – Not Captivity!" campaign to get the L.A. Zoo elephants, Ruby, Gita and Billy relocated to sanctuaries. Los Angeles Mayor Antonio Villaraigosa stated in his 2005 election campaign that "a zoo is not an appropriate place for an animal as large as an elephant ... We need to move the elephants out." We are working hard to raise awareness of this issue and we plan to hold the Mayor to his campaign promise!

Please read about these campaigns and more inside and find out what you can do to help. We hope you will continue to support LCA in 2006. We have many goals for the coming year and need your help to be successful. You are an important part of LCA. Without you, we wouldn't be there for the animals. Elephant Sanctuaries – Not Captivity! Campaign Continues

LCA continues to focus attention on Ruby, Gita and Billy, the three elephants currently housed at the Los Angeles Zoo. LCA is fighting for the elephants to be relocated to sanctuaries and does not support the proposed elephant exhibit expansion from ¾ acre to just

less than two acres at a cost of \$16 million.


Elephants do not belong in captivity as they suffer tremendously from ailments rarely seen in the wild and have much shorter life spans. Their joints and feet suffer from standing on hard surfaces and is the #1 cause of death/euthanasia of captive elephants. No zoo can adequately provide for the needs of elephants; they deserve to be relocated to sanctuaries where they can have free choice, **the space they need**, the chance to bond with other elephants and live out their lives in peace.

Mayor Villaraigosa has temporarily stopped the funding for the elephant exhibit renovation and has called for a full review of the "housing and health needs" of the elephants. He has directed the City Administrative Officer to conduct a study on the elephants which is expected to be completed by the end of the year.

We hope this study will lay the groundwork for permanently closing the exhibit and relocating the elephants to sanctuaries.

# 17th Annual Fur-Free Friday 2005

The Friday after Thanksgiving is the busiest shopping day of the year and has grown to become one of the most widely attended annual protests of the animal rights movement. LCA organized and led a protest down the streets of Beverly Hills, California ending up at Neiman Marcus, one of the country's largest purveyors of fur.

Peaceful demonstrators, guided by police escort, passed out leaflets educating passers-by about the

horrors of the

#### Pet Protection Amendment\*

With the August 2005 conviction of Class "B" dealer C.C. Baird, Senator Daniel Akaka (D-HI) was moved in September to introduce Amendment 1729, called the Pet Protection Amendment, to the Agriculture Appropriations Bill. This amendment would help protect our nation's companion animals by prohibiting federal funding to research facilities that bought animals from Class "B" dealers. (Class "B" animal dealers collect dogs and cats from "random sources" and routinely violate the Animal Welfare Act.) Although the amendment passed in the Senate, it was not approved in the final stages of conference hearings.

However, there is GOOD NEWS as the conference committee stated they strongly support strict enforcement of the Animal Welfare Act, including regulatory oversight of the trade by Class "B" animal dealers. They ordered the Secretary of Agriculture to submit a report by March 2006 on enforcement actions taken in the regulation of Class "B" animal dealers including the frequency of inspection of the dealers.



# LCA Rescues Animals in Hurricane Katrina's



LCA's President Chris DeRose organized and led one of the first rescue teams admitted into the devastated "hot zone" area of St. Bernard Parish, Louisiana, one of the areas hardest hit by the storm.

LCA's rescue team joined forces with Best Friends Animal Society's triage operation situated at the St. Francis of Assisi animal sanctuary in Tylertown, Mississippi. LCA's rescue team drove two hours back and forth each day to enter St. Bernard Parish, where approximately 70,000 people and countless animals used to live.


LCA went to work, donning protective gear to trudge through muck and sludge, searching for animals left stranded on the streets or trapped in homes, buildings and backyards. The rescue team tirelessly walked and drove up and down streets, calling and whistling out to animals...

waiting to hear a bark or any kind of response. When not on the streets, the team cared for the hundreds and hundreds of rescued animals at the sanctuary by cleaning out cages and doing whatever was needed.

LCA's rescue team fell in love with all the rescued animals, but one little Beagle mix really grabbed our hearts. She was rescued from an area where buildings had been flooded over the second story. Somehow she managed to survive four weeks in the toxic sludge of St. Bernard Parish, a

terrifying ordeal no one should have to go through. Aptly named "Katrina" by the rescue team, Chris DeRose has committed to fostering her until her guardians are found.



# Save the Mountain Gorillas Campaign

Mountain gorillas live in the forests in Uganda, Rwanda and the Democratic Republic of Congo (Zaire). They are one of the world's rarest animals and sadly, an endangered

species now. There are only about 650 mountain gorillas left in the world, and approx 300 of them are in Uganda's Bwindi Impenetrable Forest.

In January 2006, LCA will embark on supporting the gorilla conservation efforts in Bwindi's Impenetrable Forest. The Ugandan Wildlife Authority (UWA) is responsible for the gorilla's day-to-day protection. The rangers, trackers and wardens of the UWA are the front line in gorilla conservation, working hard to preserve the remaining gorilla population with ecotourism and escorted gorilla treks to see the habituated gorilla families. These treks are very restricted and help to fund future preservation efforts of the mountain gorillas.


# Second Annual Puppy Mill Awareness Day

"It's a doomed business," says Chris DeRose about the puppy mills operating in the heart of Lancaster County, Pennsylvania and across the country.

In September 2005, LCA was in Lancaster, PA, known as the "puppy mill capital of the east coast", holding the Second Annual Puppy Mill Awareness Day to demonstrate and raise public awareness of the puppy mill industry, a cruel business that churns out 500,000 dogs a year, adding to the serious problem of pet overpopulation. The dogs are used as "breeding machines," producing litter after litter of puppies. When the dogs are no longer able to breed, they are disposed of and often auctioned off to research facilities where further tortures await.

The dogs are given the absolute minimum standard of care – and no veterinary care, no decent food, insufficient water and no bedding. Puppy millers care nothing about the health or well being of the dogs. If a dog dies ... there is another to take its place.

A lot of people have heard of puppy mills, but don't really know what goes on inside them. LCA vows to expose and end this dirty business, and our protest in Lancaster was a step in that direction. Besides the march, we've started a billboard campaign to raise public awareness in the





Lancaster area about what is going on right under the public's nose. If people don't know about a problem, it will never be solved.

# How You Can Help End Puppy Mills!

- Don't buy an animal from a pet store. Go to your local shelter or rescue organization and adopt.
- Pressure government officials to ban the puppy mill business. Write letters and make phone calls. If we put enough pressure on politicians to change and enforce laws, we can make a difference.
- Boycott Lancaster County, "the puppy mill capital of the east coast."
- Talk to others and educate them about puppy mills. Word of mouth is a powerful weapon!
- Organize and hold your own peaceful puppy mill demonstration.

# Class "B" Dealer C.C. Baird CONVICTED!

JUSTICE IS FINALLY SERVED! C.C. Baird, the nation's largest USDA-licensed Class "B" animal dealer and pet theft ring operator, was convicted of civil and felony criminal charges in 2005. Baird's criminal and civil case comprised the largest multi-agency (federal, state and local) investigation of animal abuse in U.S. history, which was prompted by LCA's undercover investigation at Baird's Martin Creek Kennels. After LCA's Special Investigative Unit handed over documentation to the U.S. Attorney's office, Baird was subsequently charged with hundreds of violations of the Animal Welfare Act.

On January 28th, 2005, a consent decision was reached in Baird's civil case; Baird's USDA license was permanently revoked and he was slapped with a fine of \$262,700 (which he paid!), the largest fine ever imposed by the USDA/APHIS.

Baird also pled guilty on August 30, 2005, to felony charges of conspiracy to launder money in an operation involving the sale of dogs and cats to research laboratories. Baird's guilty plea stems from his role in mail fraud, in which he violated the Animal Welfare Act by transferring dogs and cats to research facilities with false acquisition records through his facility, Martin Creek Kennels. The charge against Baird is punishable by up to 10 years in prison and a fine of more than \$5 million. Sentencing for Baird's criminal charges is due by the end of 2005.

Baird and Martin Creek Kennels are finally out of business! Baird will no longer torture, kill, abuse, steal or sell companion animals ever again.

## The Pet Safety and Protection Act S.451

This year's conviction of violations of the Animal Welfare Act by Class "B" dealer C.C. Baird has also been instrumental in bringing much needed attention to the Pet Safety and Protection Act which was introduced in Congress by Senator Daniel Akaka in February 2005. Never before have we had such interest and support behind this bill. Baird's case is being used to gather momentum from supporters and to inform congress about this legislation. We are determined 2006 will be the year the Act is passed into law, which will ensure stolen, lost and unclaimed companion animals will not end up in the hands of Class "B" dealers to be sold to research facilities.


