Last Chance for Animals (LCA), known as "The FBI of Animal Rights," is an international nonprofit organization dedicated to fighting animal cruelty. LCA's Special Investigation Unit (SIU), conducts in-depth undercover investigations to expose horrible cruelty and misuse of animals. The SIU team focuses on validating information, detecting suspect activity, exposing illegal or unethical activities and reporting them to local, state and federal authorities for prosecution. The information obtained in LCA's investigations is used to develop campaigns, provide grassroots education and outreach to the public and draft legislation that will bring real permanent changes for animals.

LCA recognizes all animals as sentient beings that should not be subjected to exploitation by humans for food, entertainment, clothing or scientific curiosity and deserve to live their lives free from pain. LCA advocates conscious and informed lifestyle decisions and is committed to disseminating truthful information about societal animal abuse in order to improve the manner in which animals are treated worldwide.

# LCA UNDERCOVER INVESTIGATION EXPOSES ANIMAL CRUELTY AT SHEIK HALAL FARMS SLAUGHTERHOUSE: In May 2019, LCA released a 4month undercover investigation into Sheik Halal Farms, Inc, a provincially licensed meat

animal abuse, disturbing practices, and possible violations of food handling safety procedures. Additionally, LCA alleged government oversight is lacking. LCA submitted all evidence collected in two formal complaints to the Canadian Food Inspection Agency (CFIA) and the Food Inspection Branch of the Ontario Ministry of Agriculture, Food, and Rural Affairs (OMAFRA). The treatment of animals documented at Sheik Halal shows a failure to follow basic health regulations while disregarding the well-being of the birds in their care. LCA is calling for further investigation and charges to be laid against Sheik Halal Farms.

## LCA & ANIMAL LIBERATION WAVE WORKING TOWARDS STOPPING

THE DOG MEAT TRADE IN S. KOREA: In November 2017, LCA's South Korean sister organization, Animal Liberation Wave (ALW), was launched to put an end to the S. Korean dog meat trade that tortures and kills over one million dogs annually. LCA and ALW are working towards unifying the conflicting legal status of dogs to 'companion animals' only, which will effectively end the dog meat trade. Throughout 2019, LCA and our S. Korean sister organization, Animal Liberation Wave (ALW), continued the campaign to end the dog meat trade in S. Korea by holding a series of strategic events which included the "Stop the Villain Truck" campaign, actress Kim Basinger traveling to Seoul to join in the Boknal protest in front of the National Assembly in July and shutting down an illegal dog meat auction house in August. All the activities were aimed at urging the national Assembly to pass Minister of Parliament Pyo Chang-won's proposed amendment to the Animal Protection Act, which will ban the slaughter of dogs and cats for meat when passed. *StopDogMeat.com*

# COMPLAINT FILED AGINST MARINELAND CANADA FOR DISPLAYING CETACEANS AFTER PASSAGE OF CANADIAN BILL S-203: Succeeding LCA's

2015 undercover investigation into Marineland Canada and complaint to the Ontario Society for the Prevention of Cruelty to Animals for violations of the OSPCA Act and its prescribed standard of care, LCA filed a complaint in June 2019 with the Ontario Ministry of the Solicitor General against Marineland Canada based on performances of cetaceans (i.e., whale, dolphin, or porpoise). The complaint was filed after the passage of Bill S-203 received Royal Assent on June 21, 2019, which led to the creation of new animal cruelty provisions in the Criminal Code of Canada. These provisions impose restrictions on keeping whales, dolphins and other cetaceans in captivity. These sections allow organizations that had cetaceans before the bill came into effect to keep the cetaceans but impose restrictions on their handling. The new animal cruelty provisions at section 445.2(4) of the Criminal code set out that:

(4) Every person commits an offence who promotes, arranges, conducts, assists in, receives money for or takes part in any meeting, competition, exhibition, pastime, practice, display or event at or in the course of which captive cetaceans are used, in Canada, for performance for entertainment purposes, unless the performance is

authorized under a license issued by the Lieutenant Governor in Council of a province or by an authorized authority.

LCA attended, observed, and took video recordings at the dolphin show at Marineland on August 6, 2019. The show took place in a stadium in front of an audience. Marineland sold tickets to patrons to allow them access to the park and to watch the dolphin show. Dolphins are seen numerous times throughout the show performing tricks in front of an audience.

At the same time of LCA's attendance, tickets were also available for purchase for encounters with Beluga whales. LCA witnessed at the Beluga whale encounter that patrons were permitted to pet and touch Beluga whales. LCA's complaint calls on the Ontario Ministry of the Solicitor General to investigate.

## FIGHTING AGAINST BELUGA WHALES BEING EXPORTED FROM

MARINELAND CANADA TO THE U.S.: Mystic Aquarium in Connecticut filed a permit application to import five Beluga whales from Marineland Canada for scientific research. Under the US Marine Mammal Protection Act (MMPA) and the Canadian Wild Animal and Plant Protection and Regulation of International and Interprovincial Trade Act, the laws do not allow for this importation. The five Belugas proposed for import descend from the depleted Sakhallin Bay-Nikolaya Bay-Amur River population in the Russian Federation. The MMPA clearly states there should be no public display of marine mammals from depleted populations. Otherwise, the relevant MMA exemption for importing depleted marine mammals for scientific research would be a massive loophole to get animals for public display and breeding. June 2019's passage of Canadian Bill S-203 made displaying cetaceans for entertainment purposes illegal and placed restrictions on importing, exporting, and breeding. LCA is urging the National Marine Fisheries Services to deny the import permit application by Mystic Aquarium and calling on Canada's Minister of Environment and climate Change and the Honourable Jonathan Wilkinson to deny the export permit.



FIGHTING AGAINST UNCONSTITUTIONAL AG-GAG LAWS: LCA monitors pending ag-gag legislation and campaigns against bills as they arise. On May 15<sup>th</sup>, 2019, Texas Ag-Gag Bill 1884 - relating to the protection of animal and crop facilities; creating a criminal offense – passed the Texan House Agriculture & Livestock Committee. LCA conducted a campaign urging Texas citizens to contact their legislators and voice opposition to the bill. Legislators had until midnight on May 21<sup>st</sup>, 2019 to vote on the bill, however, the bill was not brought up for a vote and the freedom-crushing bill was officially dead after not being heard. Since it was the last day of the legislative session, the bill cannot be heard until the next legislative session in 2021. EndAgGagLaws.com



# LCA'S CASA DE CARNE WINS TARSHIS SHORT FILM AWARDS FIRST PLACE PRIZE & 6 TELLY AWARDS: LCA won first place and a \$3,000 cash prize

from the Tarshis Short Film Awards for *Casa de Carne* that premiered at the 2019 Animal Film Festival. *Casa de Carne* follows three friends in a not-so-distant and dark future who must slaughter the animals they order for dinner at a high-end restaurant. The thought-provoking film about hard choices and hidden truths won first place for its impact highlighting issues of animal suffering in food production.

Casa de Carne went on to win six Telly Awards, one Gold, two Silver and three Bronze in the Social Responsibility for Non-Broadcast, Cause Marketing for Online Commercials, Social Responsibility for Online Commercials, Public Interest/Awareness for Online Commercials, Directing for Online Commercials, and social Issues for Non-Broadcast categories. One of the world's most prominent and highly respected competitions for honoring video and television content, the 40<sup>th</sup> Annual Telly Awards received over 12,000 entries from all 50 states and five continents.



# PROTESTS AGAINST PROFESSIONAL BULL RIDER'S "UNLEASH THE

**BEAST" TOUR:** LCA led a coalition of celebrities, activists and animal rights

organizations to protest the exploitation and abuse of bulls during the Professional Bull Riders competition at the Staples Center in February & September 2019. The protests were aimed at educating the public about the torment bulls endure inside and out of the ring and to urge the Los Angeles City council to ban rodeos and rodeo-type sporting events within the city. Bull riding is a dangerous and cruel rodeo "sport" that jeopardizes both the human rider and the bull. A growing number of jurisdictions already have rodeo prohibitions or restrictions in place. These include Fort Wayne, IN; Pittsburg, PA; Southampton, NY; Pasadena, CA and Chino Hills, CA. Outside of the United States are Auckland, New Zealand; parts of Brazil; Quebec, Canada; and the United Kingdom. *StopBullRiding.com*

## SAVING MOUNTAIN GORILLAS AND SUPPORTING VIRUNGA NATIONAL

PARK'S AIRWING: For over a decade, LCA provided long-standing support to the Ugandan and Rwandan Wildlife Authorities in the conservation of the critically endangered mountain gorillas. In 2016, LCA's campaign turned to supporting the AirWing of war-torn Virunga National Park in the Congo where rangers risk their lives daily to protect the land and the wildlife from poachers and rebel militia. A functional and modern AirWing program provides the best possible tool to secure the park and reduce threats to Virunga's rangers and wildlife population.

Virunga, in the Democratic Republic of the Congo, Africa's oldest and most biologically diverse park, is home to a quarter of the last remaining 1,000 mountain gorillas. Even though Virunga has been declared a UNESCO world heritage site, rebel militia are illegally stripping the park of natural resources and poaching the wildlife.

In 2019, LCA provided supplies for the airplanes, a new roof for one of the hangars and a MSA Gallet LH250 Flight Helmet for Anthony Caere, Head of Virunga's AirWing. Construction of a new hangar to house the airplanes and ranger quarters are currently underway.

The brave Virunga rangers risk their lives daily protecting the park and the wildlife, including the majestic mountain gorilla. Without the bravery and sheer determination of Virunga's rangers, staff, and the AirWing program, the park and the wildlife would cease to exist. *LCASavingGorillas.org* 



EXPOSING ANIMAL CRUELTY – MILLBANK FUR FARM, CANADA: The case against Millbank is still moving through the court system as of December 31, 2019. If convicted on all charges, Millbank Fur Farm faces the maximum fine of \$840,000 and 28 years in prison – two years per charge. LCA's groundbreaking investigation of Millbank Fur Farm Ltd. is the first time an undercover investigation in Ontario, Canada has led to charges and is the first in-depth undercover probe of a fur farm producing pelts

for the Canadian fur industry – an industry that kills more than three million animals for fur each year.

LCA's investigation, conducted over the course of a year, exposed disturbing accounts of animal neglect and suffering amongst the 40,000 mink that live, and die, at the farm annually. LCA submitted all evidence collected in a complaint to the Ontario Society for the Prevention of Cruelty to Animals (OSPCA). In February 2018, the OSPCA launched their own investigation into the farm and, three months later, charged Millbank Fur Farm with 14 counts of animal cruelty, stating: "No one is exempt from the law."

**FUR-FREE FRIDAY PROTEST**: On Black Friday, the day after Thanksgiving, 11/29/19, LCA, along with a coalition of animal rights organizations and supporters, led the 33rd annual Fur-Free Friday protest in Beverly Hills, CA. Hundreds of protestors marched peacefully along Rodeo Drive to demand retailers still selling fur to commit to going fur-free immediately, not in 2023 when the California fur ban takes effect. # **Public Education and Outreach:**



Animal News Van: LCA and the Animal News Van (ANV), attends special events, conferences, schools and fundraisers. LCA's custom-made, donated ANV is equipped with two large plasma televisions screens, a speaker system and led ticker tape. The ANV uses the powerful medium of video to educate citizens about the current conditions animals live in by showing investigative reports and disseminating breaking news stories. Attendees at each event range from 30-300.

LCA's ongoing educational campaigns include extensive efforts to educate the public about animal suffering and ways to combat it using peaceful and lawful methods such as petition-signing, letter-writing, civil disobedience demonstrations and product boycotts. Special emphasis is given to schools to encourage the younger generation to adopt a compassionate, cruelty-free lifestyle.

Throughout the year, LCA was interviewed for television and radio shows, online news outlets and conducted numerous lectures at educational institutions. LCA also organized and attended civil disobedience demonstrations, tabling events and conferences with leaflets and petitions, educating the public about animal cruelty and what can be done to stop it.

<u>Social Media & Websites:</u> LCA strives to educate the public about animal issues through websites, email alerts and social media. These educational tools are valuable resources for the public as they contain information on a variety of animal rights issues, encourage readers to take action and provide an opportunity to update members about LCA's programs. Financial Information: LCA is a nonprofit, tax-exempt 501(c) (3) organization funded by over 180,000 individual donors around the globe. LCA allocates expenditures to Programs, Fundraising and Management/General.

**Programs** include expenses directly related to LCA's work to expose and end animal cruelty and abuse. This includes funding for program activities of undercover investigations and campaigns, purchasing investigative equipment, working with the media and government entities and creating informational materials to inform people about animal exploitation.

**Fundraising** includes expenses, which have a primary purpose of raising revenue to allow LCA's mission and work to continue. This includes efforts to solicit donations and expenses related to those efforts. 20 percent of direct mail costs is fundraising expense and 80 percent is the program cost of educating our members and calling them to action.

**Management/General** includes expenses for supporting and maintaining the business side of LCA and includes filing paperwork with appropriate agencies to ensure LCA operates as a responsible and legal nonprofit organization.

Depending upon the nature of the staff position, salaries vary in their percentage reported as program, fundraising and management/general expense.
