LCA's main website (WWW.LCAnimal.org) receives over 400,000 hits a month. Social media accounts include FaceBook (over 357,700 followers), Twitter (over 8,900 followers), Instagram (14,800 followers) and YouTube (over 40,258 followers and over 3,313,000 views). LCA's e-mail action alerts ask for "Calls to Action" from members about issues needing urgent attention. Members are e-mailed information and asked to send an e-mail, letter or fax, make a phone call and post on social media to help bring about needed changes for animals.

LCA's founder and president, Chris DeRose, is frequently interviewed for television and radio programs, newspapers and magazines, nationally and internationally. He also travels both in the U.S. and abroad, giving lectures and educating the public about animal rights. Countless people have read or heard about LCA and Chris DeRose through the 15-20 interviews in 2021.

Locally, LCA and the Animal News Van (ANV), attend special events, conferences, schools and fundraisers. LCA's custom-made, donated ANV is equipped with two large flat screen television screens, a speaker system and LED ticker tape. The ANV uses the powerful medium of video to educate citizens about the current conditions animals live in by showing investigative reports and disseminating breaking news stories. Attendees at each event range from 30-300.

that would ban the use of inhumane implements - such as electric prods, flank straps, and spurs or rowels - which force rodeo animals to perform. Councilmembers must hear from constituents for the Motion to move forward.

In 2021, LCA rallied supporters, via email action alerts, social media posts and information on www.StopBullRiding.com, to make public comment on the L.A. City Council File 20-1575. LCA sent letters to each councilmember and was the first to post a public comment. The Ordinance is being drafted by the City Attorney's office and will need to be voted on again by City Council members once it is released.

In September 2021, LCA's undercover surveillance of the Professional Bull Riding rodeo at the Honda Center in Anaheim, CA on September 10th & 11th was shown to a veterinarian and former Professional Bronc Rider who provided expert analysis, concluding, "overall, these bulls are forced to buck beyond their normal bucking patterns which makes them susceptible to injuries including broken legs." The video, which included the expert's comments, was sent to L.A. Councilmembers to urge passage of the Ordinance.

LCA posted 20 billboards around L.A. to raise public awareness during October 2021 in support of the Ordinance. The billboards read, "L.A.: Help Ban Torture Devices at the Rodeo" and directed onlookers to take action at www.StopBullRiding.com.

Working Towards Stopping the Dog Meat Trade in South Korea - LCA launched S. Korean sister organization, Animal Liberation Wave (ALW), in November 2017 with one mission in mind - to work 24/7 putting an end to the S. Korean dog meat trade that tortures and kills over one million dogs annually. Along with global outcry, a strong, public

anti-dog meat movement must be mobilized within S. Korea to make real changes at the national level.

A new dog slaughter ban was introduced in December 2020 for the current 2020-2024 South Korean National Assembly. The bill is an amendment to the Animal Protection Act prohibiting the act of slaughtering and processing of dogs and cats to use or sell for food. The bill states that "the perception that dogs are pets/companions is prevalent around the world" and that "China Taiwan, and others have recently taken measures to phase out dog meat consumption."

During 2021, LCA/ALW and supporters dropped a massive 100' x 100' Stop Dog Slaughter banner from a prominent building in one of Seoul's busiest districts. The banner featured a photo of a slaughtered dog taken during LCA/ALW's undercover investigation into the Moran Market (a.k.a. the mecca of dog meat) and was aimed to mount pressure on the National Assembly to pass the dog slaughter ban.

LCA/ALW rescued nine dogs from a South Korea dog meat slaughterhouse in July 2021 as a result of a raid on two illegal dog slaughterhouses in Yeoju City. The slaughterhouses had been documented by LCA/ALW as part of an extensive, eight-month undercover investigation into facilities supplying dog meat to Moran Market. During the raid, activists staged a peaceful protest outside to mourn the dogs who have been killed in the dog meat trade and demanded an end to dog slaughter nationwide.

The nine dogs rescued traveled from Seoul, South Korea to Los Angeles between September and November 2021. LCA/ALW partnered with START Rescue to coordinate the U.S. adoptions. Many of the dogs were traumatized and needed training, extra care,

socializing and loving attention before being adopted out to their new, forever homes in California and Oregon.

With "boots-on-the-ground," LCA and ALW will continue to work toward ending S. Korea's brutal dog meat industry. www.StopDogMeat.com

Fur-Free Friday and Global Fur Ban - During 2021, LCA was part of the Fur Free Alliance, a global coalition of over fifty animal rights groups worldwide, calling for a global ban on fur farming. LCA's petition to Ban Fur Globally collected over 72,000 signatures and were part of the 880,000 total signatures gathered from members of the Fur Free Alliance that were delivered to the G20 yearly summit meeting held in October, 2021 in Rome, Italy. The petition was aimed at the G20 members to encourage world leaders to take steps to publicly declare fur farming must end globally. The G20 is comprised of 20 member countries, representing 60% of the world population, and is a strategic multilateral platform connecting the world's major developed and emerging economies and holds a strategic role in securing future global economic growth and prosperity.

LCA's 35th Annual Fur Free Friday demonstration was held on Black Friday, November 26, 2021, and called on governments and retailers to Ban Fur Globally and Stop Selling Cruelty. Demonstrators marched along Rodeo Drive in Beverly Hills, CA, protesting outside retailers still selling fur (including Dior, Louis Vuitton, and Dolce & Gabbana). The protest was attended by over 200 dedicated activists along with a video billboard truck that played LCA's Millbank Fur Farm investigative footage and showed graphic images of the extreme cruelty inflicted on animals by the fur industry. Protestors also encouraged Beverly Hills stores to go fur-free

immediately and not wait until 2023 when the California state fur ban will go into effect.

LCA works with a coalition of U.S. animal advocacy groups to promote passage of anti-fur legislation. LCA rallies supporters to contact their elected officials to get them to support anti-fur legislation. A municipal retail fur sales ban successfully passed in August 2021 in Ann Arbor, Michigan. An anti-fur bill in Rhode Island did not pass and Massachusetts and New Jersey anti-fur bills have been introduced in legislature.

Fighting Ag-Gag Laws in North America - During 2021, LCA's legal team successfully publicly presented to the legislative assembly of Manitoba, Canada regarding Bill 62 - the Animal Diseases Amendment Act that would impair undercover investigations into animal cruelty in agriculture. LCA presented to the Manitoba legislature on the issue (see page 420) Bill 62 - the Animal Diseases Amendment Act. The bill passed on 05/20/2021, however, problematic language that would have made whistleblowing a crime was not included in the final bill.

LCA successfully fought against the passing of a Federal ag-gag law in Canada, Bill C205, that could have impaired undercover employment-based investigations into animal agriculture across Canada. LCA prepared written submissions about the need for transparency to the Standing Committee on Agriculture and Agri-Food and set up an email action to easily connect Canadians with their Members of Parliament. The Bill died in Committee on 08/15/2021.

LCA rallied Texan supporters via email alerts to contact their House & Senate

Representatives against HB 1480/SB 472, an amendment to the agricultural code introduced in January 2021, which sought to create an ag-gag law in Texas. Although the legislation ultimately passed on 6/18/2021, it was amended to remove problematic language that would have criminalized whistleblowing in animal agriculture.

LCA's undercover investigations provide documentation to show the public what happens in animal industries and to bring charges against animal abusers. Ag-Gag laws are aimed at stopping the flow of information on how animals are treated in animal agriculture.

Public Outreach and Education - Saving Africa's Mountain Gorillas (Continued)

There are only approximately 1,000 mountains gorillas left in the world. They are in the Virunga Volcanoes Massif mountain range in Uganda, Rwanda and the Congo, and in Bwindi Impenetrable Forest in Uganda. In 2016, LCA's campaign turned to supporting the AirWing program of war-torn Virunga National Park in the Congo, where rangers risk their lives daily to protect the land, the natural resources, the wildlife and the majestic mountain gorilla from poachers and rebel militia.

In the last 20 years, over 230 Virunga rangers have lost their lives in the line of duty protecting the park and the wildlife. Virunga Park's AirWing is the "eye in the sky" and utilizes 206 Cessna planes and BatHawk aircraft, donated by LCA, to protect the park, the animals, medivac the injured and transport fallen Rangers back home to their families.

A functional and modern AirWing program provides the best possible tool to secure

the park and reduce threats to Virunga's rangers and wildlife population.

In 2021, LCA supplied the AirWing program with a 4th BatHawk aircraft, a replacement engine for a previously supplied BatHawk aircraft, night vision goggles for Virunga Rangers, rebuild of parts for a Cessna 206 aircraft, supplies for the BatHawks and 206 aircrafts, 2 Spider tracking systems and sponsorship of the Virunga rangers pilot training program.

Construction was completed on a new hangar and ranger quarters that began in 2020 at Katale/LCA Airfield near Virunga's headquarters to safely house the rangers and the growing fleet of the AirWing's aircraft. www.LCASavingGorillas.org

Investigations (Continued)

The SIU team focuses on validating information, detecting suspect activity, exposing illegal or unethical activities and reporting them to local, state and federal authorities for prosecution. The information obtained in LCA's investigations is used to develop campaigns, provide grassroots education and outreach to the public, and to help in drafting legislation that will bring lasting changes for the animals. The scope of LCA's investigations includes, but is not limited to: pet theft, class "B" dealers, puppy mills, Asian dog meat trade, pound seizure, circus cruelty, elephants in captivity, animals used in entertainment, vivisection and pharmaceuticals manufactured from the demise of animals.

LCA's Undercover Investigation of Millbank Fur Farm Finalized - LCA's 2017-2018 investigation of Millbank Fur Farm was the first time an undercover investigation in

Ontario, Canada led to charges. LCA exposed disturbing accounts of animal neglect and suffering amongst the 40,000 mink that live, and die, at the farm annually. This investigation is the first in-depth undercover probe of a fur farm that produces pelts for the Canadian fur industry, which kills more than three million animals for fur each year.

Over the course of a year, LCA's undercover investigator documented horrific cruelty and gathered evidence revealing rough handling of animals, unsanitary conditions, sick animals living with open, untreated wounds and infections, lack of food and unsanitary shelters. During the investigation, LCA's investigator never saw a veterinarian on site.

LCA submitted all evidence collected in a complaint to the Ontario Society for the Prevention of Cruelty to Animals (OSCPA). In February 2018, the OSCPA launched their own investigation into the farm and 3 months later, in May, charged Millbank Fur Farm with fourteen counts of animal cruelty, stating, "No one is exempt from the law."

The court case against Millbank was delayed due to COVID-19. In March 2021, Millbank pleaded guilty in the Ontario Court of Justice in Guelph, Ontario with failing to comply with prescribed standards of care under section 11.1(1) of the Ontario Society for the Prevention of Cruelty to Animals Act. Millbank paid over \$148,000 USD making improvements to its facilities in the areas of animal welfare record keeping; employee training; animal housing; and euthanasia practice. The improvements were verified in inspections by Ontario's Provincial Animal Service (PAWS). In addition, Millbank was ordered to pay a monetary penalty of \$5,600 USD to the Ontario government. www.LCAnimal.org/Millbank

LCA's Undercover Investigation into the South Korean Dog Meat Trade - LCA, working with South Korean sister organization Animal Liberation Wave (ALW), released a comprehensive, 8-month undercover investigation (October 2020 - May 2021) into South Korea's dog meat industry that focused on the Seongnam Moran Market, aka the "Mecca of Dog Meat" and facilities related to the market. In North America, LCA/ALW's investigation video was narrated by actress and activist Kim Basinger, and the South Korean video was narrated by actress and activist Lim Semi. Investigators documented systemic cruelty to dogs at farms, auction houses, and slaughterhouses. Throughout the investigation, LCA/ALW documented an ongoing pattern of animal abuse in clear violation of animal protection laws and filed animal cruelty complaints with officials in South Korea. The investigation was covered extensively by all major media outlets in South Korea.

LCA/ALW, working with Police, Animal Protection Officers, Journalists and Activists, raided two illegal slaughterhouses documented during LCA/ALW's 8-month undercover investigation. As a result of the raids, the slaughterhouses were closed down, lawsuits were filed, and charges and fines were issued to the owner and employees of the slaughterhouse. During the raid, LCA/ALW and supporters staged a peaceful protest outside the slaughterhouses to mourn the dogs who have been killed in the dog meat trade and demanded an end to dog slaughter nationwide.

LCA's Legal Complaint Leads to Charges Against Marineland Canada for Performances -LCA's investigator attended Marineland performances and documented dolphins doing flips, spinning, having a "dolphin dance party" and performing other tricks on command to music in front of a live audience. Beluga whales were also documented being

instructed to perform tricks for food in front of park attendees. LCA filed a legal complaint in September 2021 with the Niagara Regional Police Service based on concerns that Marineland violated a provision of the 2019 Canadian Bill S-203: Ending the Captivity of Whales and Dolphins Act which prohibits cetaceans (whales, dolphins and porpoises) from being used for entertainment purposes.

The Niagara Regional Police Service announced in December 2021 that Marineland Canada was being charged with violating provisions of the Ending the Captivity of Whales and Dolphins Act based on LCA's legal complaint. The police charged them with using dolphins and whales for entertainment performances during the month of August 2021 without being authorized to do so under the Act. LCA featured prominently in the US and Canadian media coverage of the charges against Marineland.
